We, the undersigned, jointly, severally, and in common, covenant to hold Releasees harmless and to indemnify Releasees from any claim, judgement or expenses Releasees may incur arising out of any of the minor's activities or presence in the arena area.
- 2. RELEASOR or parents or guardians of the undersigned minor AGREE TO INDEMNIFY the Releasees and each of them from any loss, liability, damage or costs they might incur due to the presence or participation of the minor in to described activities, whether caused by the negligence of the Releasees or otherwise.
